 - (a) The firms should have two years of experience of having undertaken similar jobs in Ministries/Departments of the Government/autonomous body/PSUs supported by proper documents.
 - (b) The firm should send samples of the paper.
 - (c) The complete work should be perfect to the requirement and satisfaction of the Ministry.
 - (d) Soft copy of the material of Citation Book will be provided. You are advised to see/obtain a sample copy of previous Citation Book for your reference.
 - (e) Tender would be awarded to the firm whose total cost is the lowest
 - (f) The agency which has been blacklisted by any Department/Office/Organisation of Ministry of Youth Affairs & Sports will not be eligible to submit tender.
- 4. EMD for Rs. 3,000/- in the form of demand draft/ Bankers Cheque in favour of "Accounts Officer, PAO (Sports)", issued by any nationalized bank payable at Delhi valid for a period of 45 days beyond the final bid validity period.
