
- (a) The bidding firm should have good conditions of buses and cars. All the cars/buses must have valid permit to run in the territory of Delhi with drivers having valid driving license.
- (b) Contracted hire charges will include everything including parking charges. No additional payment will be made by the Ministry under any circumstances except extra hours and KMs, if exceeds the day limit of 8 hours and 80 KMs.
- (c) A daily record indicating time and mileage for each vehicle shall be maintained separately in Duty Slip.
- (d) The firms should have two years of experience of having undertaken similar jobs in Ministry/Department of the government/autonomous body/PSUs supported by proper documents.
- (e) No denial will be accepted from the firm after the contract is awarded to the firm.

2. The quotation should be submitted in a sealed cover/envelop should be superscribed "**Quotation for Transport**" (as per Annexure-I) and it should contains all technical details i.e. copy of return file I. Tax i.e. A.Y. 2018-19, experience.

3. The quotation can be submitted in the office by 02.09.2019 by 2.00 and quotation will be opened on the same day at 2.30 pm in the presence of representatives of bidders, who will be present at that time. Those who not fulfill the conditions, quotation will be rejected at any time..

4. If the work of the contractor is found unsatisfactory, the contract can be terminated by this office at any time without assigning any reason. In this respect, the decision of the Ministry shall be final and binding on the Contractors. The Ministry reserves the right to reject any quotation in whole or in part without assigning any reason.
