It is proposed that participants of Republic Day Parade Camp, 2024 may visit in condition which, called from the PM House, Vice President House and Rashtrapati Bhawan, where cultural team of NSS volunteers will present cultural programme. Quotations are invited from the interested vendor/person to choreograph with cultural team of NSS Republic Day Parade Camp, 2024 on the following terms & conditions:-

**Terms & Conditions:-**

- (a) Proof of Choreography with any organization.
- (b) Copy of income tax return filed i.e. A. Y. 2023-24.
- (c) Choreographer will attend the camp on regular basis from 1<sup>st</sup> to 31<sup>st</sup> January, 2024.
- (d) No denial will be accepted from the firm/choreographer after the contract is awarded to firm/them.
- (e) Choreographer should complete the preparation work with cultural team before 20<sup>th</sup> January, 2024.
- (f) Costumes will be arranged by the choreographer on rent basis. The rent will be paid by the organizer.
- (g) Music, CD, instruments, which will be used, has to be arranged by the choreographer for which no extra payment will be borne by the organizer.
- (h) Those that do not fulfill the conditions, quotation will be rejected at any time.
- (i) This year the theme of all cultural performance will be "Nari Shakti" so the performance will be as per the requirement.


3. The bid may be given in **one sealed envelope**, superscripted "**Rates for choreographer.**"
