It is proposed that participants of Republic Day Parade Camp, 2025 will visit in condition which, called from the PM House, Rashtrapati Bhawan, where cultural team of NSS volunteers will present cultural programme. Quotations are invited from the interested vendor/person to choreograph with cultural team of NSS Republic Day Parade Camp, 2025 on the following terms & conditions: -

Terms & Conditions :-

- (a) Proof of Choreography with any organisation.
- (b) Copy of income tax return filed i.e. A. Y. 2024-25.
- (c) Choreographer will attend the camp on regular basis from 1st to 31 January, 2025.
- (d) No denial will be accepted from the firm/choreographer after the contract is awarded to firm/them.
- (e) Choreographer should complete the preparation work with cultural team by 20th January, 2025.
- (f) Costumes will be arranged by the choreographer on rent basis. The rent will be paid by the organiser.
- (g) Music, CD, instruments, which will be used, has to be arranged by the choreographer for which no extra payment will be borne by the organiser.
- (h) Those that do not fulfill the conditions, quotation will be rejected at any time.

3. The bid may be given in **one sealed envelope**, superscripted **"Rates for choreographer."**

- (i) Quotation should be submitted as per **Annexure-I**. It should contain all details i.e. copy of PAN card, I. Tax return file for the A.Y. 2024-25, experience etc.

4. The contract can be terminated by this Office at any time without assigning any reason, if the work of the contractor/choreographer is found unsatisfactory. In this respect, the decision of this Office shall be final and binding.
